## Estate Checklist

This information <u>is not</u> intended to replace the advice from an attorney or licensed estate planner.

#### Handling the Estate

After you have completed the funeral arrangements for your loved one, you will eventually address the financial matters associated with the estate: all of the deceased's assets (real and personal property) and the estate's liabilities (the money the estate is obliged to pay).

#### Getting started:

The Executor/Administrator of the estate may forward the deceased's mail in person at a U.S Post Office. Please visit **usps.com/manage/mail-for-deceased.htm** for required documentation and detailed information. You may also register a deceased individual at **dmachoice.org** to discontinue some or all direct mail (catalogs, advertisements) to the residence.

#### Gather the necessary documents of the deceased:

- Social Security number
- □ Will and trust declarations
- Death certificate
- □ Marriage certificate(s)
- □ Divorce decrees(s)
- □ Military discharge papers (DD-214)
- $\Box$  Bank statements, checkbooks, similar documents
- $\Box$  Safe-deposit box, documents, keys
- □ Insurance policies

- □ Medical □ Auto ( □ Home (Deed) □ Other
- $\Box$  Auto (Title, Leases)  $\Box$  Disability
- □ Pension–retirement benefits
- Previous vear's tax return

- □ Any documentation of business ownership or business interests
- □ Final and outstanding health insurance claims
- □ Unpaid bills (*Utilities, phone, mortgage, etc.*)
- □ Social Media Accounts (usernames and passwords)

After locating the documents, it is helpful to obtain phone numbers and the contact person for each resource.

#### Additional considerations:

- Someone to recite Kaddish
- □ Order a memorial plaque at your place of worship
- $\hfill\square$  Contact Chicago Jewish Funerals to order the monument
- Plan the dedication ceremony with Chicago Jewish Funerals anytime after 30 days of service/burial
- □ Mail acknowledgement cards

## Social Security Benefits

The State of Illinois will notify Social Security as part of the death certificate registration process. Social Security will contact the family by mail, within two months of the death, to communicate survivor benefits for the surviving spouse and minor or disabled children. The Social Security office can be contacted by phone, 800-772-1213, or through their website, **ssa.gov**.



### Veteran Burial and Memorial Benefits

#### Eligibility

Veterans discharged from active duty under conditions other than dishonorable and service members who die while on active duty, as well as spouses and dependent children of veterans and active duty service members, may be eligible for VA burial and memorial benefits. The veteran does not have to predecease a spouse or dependent child for them to be eligible. For the reserves or National Guard, eligibility is not established by active duty for training.
